

Coach Rocky Lamar

Coach Lamar is in his 31st year at the helm of the Pioneers. The MNU 1976 graduate has collected 712 of the school's 900+ wins. Before Coach Lamar began his tenure at MNU, the Pioneers had just 6 winning seasons, three of them coming while he was a player for the Pioneers. The Pioneers had also never experienced a 20-win season. Now they have won at least 20 games in 23 out of the last 27 seasons. He has averaged 23+ wins in his 30 years at MNU. His successful camps are patterned after the legendary coach John Wooden's. The Pioneers finished in the final four in 2001, 2006, 2007, 2008, 2014 and 2016 and won a National title in March 2007. Coach Lamar became a member of the NAIA Hall of Fame 2013-2014.



Coach Matt Keeley

Coach Matt Keeley is in his 8th season as the lead assistant for the MNU Pioneers. Coach Keeley played 4 years for Coach Lamar and led the Pioneers to their first national title game in the 2000-2001 season. Matt was a 2nd team All-American in his playing days at MNU and had an amazing record of 111 and 35 in his 4 years at MNU. In his 8 years as the lead assistant for the Pioneers, the Pioneers have won over 155 games, 4 conference titles, and gone to the National Tournament 4 times including a Final Four finish in 2014 and 2016. Coach Keeley has been an integral part of the Coach Rocky Lamar Basketball Camp since the summer of 2000 and has become a great teacher of the game.
